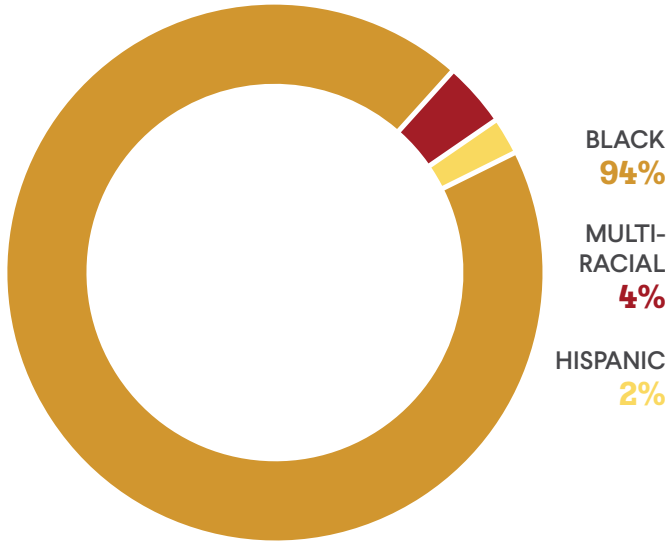

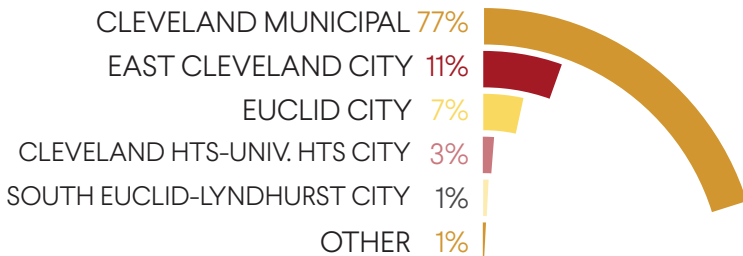

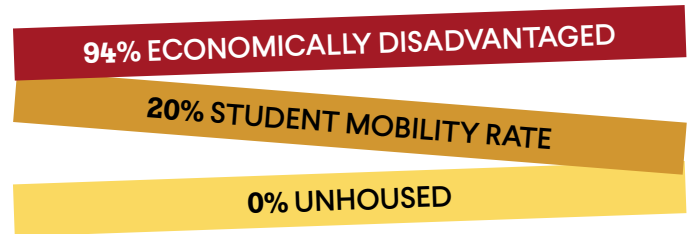
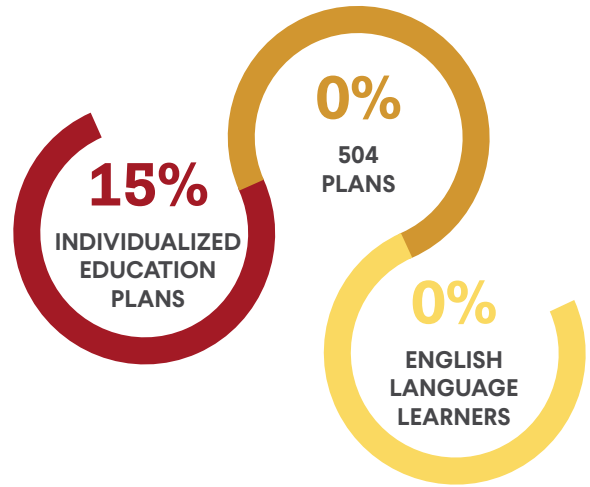
DISTRICTS OF RESIDENCE

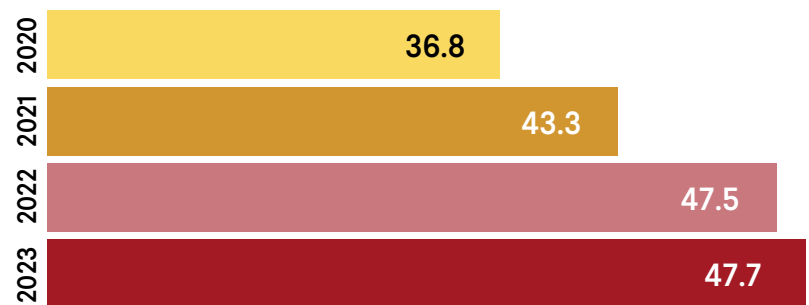
ACADEMIC PROGRESS

East Academy fell just shy of goals, with 63% of students gaining 1+ years of growth in Reading and 62% in Math.

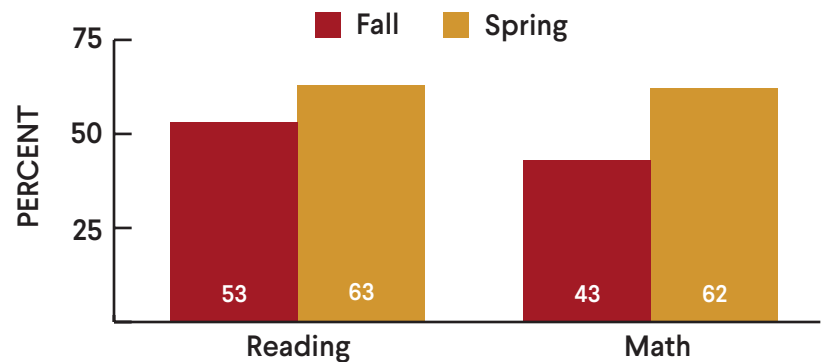
YOY PERFORMANCE INDEX SCORE

St. Aloysius, as the sponsor of this school, is legally mandated to provide oversight, monitoring, and technical assistance.
